**The method to be used to determine the order of priority in which each of the persons interested in purchasing any of the specified residential properties may select the residential property that the person wishes to purchase:**

All specified residential properties will be available for selection and purchase on a first come first served basis to any person interested in purchasing the specified residential properties.

所有指明住宅物業以先到先得形式供任何有意欲購買指明住宅物業的人士揀選及購買。

A person interested in purchasing the specified residential properties shall submit the following to the Vendor at the Sales Office (i.e. 1/F, The Uptown, No.8 Maidstone Road, Tokwawan, Kowloon):

The Purchaser shall on spot pay the balance of the preliminary deposit by cashier order or cheque. Failure to pay the balance of the preliminary deposit by the Purchaser in respect of any preliminary agreement for sale and purchase shall be deemed as that Purchaser failing to enter into preliminary agreement(s) for sale and purchase for all the selected specified residential property(ies), in which event the Vendor shall have no obligation to enter into any preliminary agreement for sale and purchase with that Purchaser and the Purchaser will be deemed to have given up the right to select and purchase any specified residential property(ies).
